This is to respond to your letter of October 22, 2008 in which you, among other things, indicate that your client Oak Harbor Freight Lines is willing to meet in mediation to discuss the Union's offer of October 9, 2008.

As you are aware, Local 174, and other Teamster Local Unions affiliated with Joint Council No. 28 in sympathy with Local 174, went on strike to protest numerous blatant unfair labor practices committed against Local 174's Oak Harbor members. The Union is willing to meet to discuss its October 9, 2008 offer only with the understanding by both parties that the Union is not waiving its legal position that the strike is an unfair labor practice strike. It is the Union's position that the unfair labor practices must be remedied through the NLRB.

The Union suggests that the parties meet with the mediator from October 29 through October 31 at the Joint Council 28 offices for three successive days of negotiations in order to make every effort to reach settlement on a collective bargaining agreement. It is further suggested that one of the top managers of the Company with decision making authority be present in the negotiations.
